Single Collateral Management     Rulebook for Europe (SCoRE) - updates	
2.1. SCoRE Triparty Collateral  Management Rulebook – 2021 update	<ul> <li>The SCoRE Triparty Collateral Management Standards (Rulebook) have been updated and written feedback is welcome by 9 April 2021.</li> <li>Feedback from market participants is requested on (i) Cancellation of future matched instructions and (ii) Modification handling by 29 March 2021 (see presentation of the meeting with specific questions).</li> </ul>
2.2. SCoRE Corporate Actions Rulebook – 2021 update	<ul> <li>The SCoRE Corporate Actions Standards (Rulebook) have been updated and written feedback is welcome by 16 April 2021.</li> <li>On Business Day Rule (Standard 6), members agreed on the content of the Standard. Members are invited to provide feedback on the governance to ensure implementation for newly issued securities, i.e. whether (I)CSDs should (i) check/inform issuers, (ii) update CSD operating rules to reject non-compliant issuances, (iii) have a disincentive or (iv) other measure. Feedback by 29 March 2021 (on the governance topic).</li> <li>On Payment Time (Standard 8), the fact-finding showed large compliance in the national EU markets. A further payment breakdown is requested for the international market from the ICSDs in four groups, i.e. (i) euro and DK,</li> </ul>

	(ii) other European currencies (iii) Americas and (iv) Asia from the ICSDs by 9 April 2021 (with granular data).
2.3. SCoRE Billing Processes Rulebook  – debriefing on the 2021 update	<ul> <li>Item postponed to the next CMH-TF call (to finalise the messaging syntax for the Billing Standards).</li> <li>The monitoring of the intermediary milestones for Billing Standard 1 will take the pending finalisation of the message update into account.</li> </ul>
3. Monitoring implementation – Updated Adaptation Plans and SCoRE Surveys H1/2021	<ul> <li>Most Adaptation Plans have been updated. The CMH Secretariat will send reminders to NSGs that did not yet submit the Adaptation Plans.</li> <li>The CMH Secretariat will review and send requests for clarifications on the Adaptation Plans to the NSGs by 23 March 2021.</li> </ul>
